17.001 Apologies

17.002 Minutes

The minutes of the Parish Council Meetings held on 9th November, 2016 were unanimously agreed and duly signed by the Chairman.

17.003 Declarations of Interests

The Chairman closed the meeting for the following items:-

17.004 RAF

The following areas were presented and discussed with FO Lismore and WC Stacey:-

- the surprise announcement on 9.12.16
- there will be ongoing dialogue with the Chairman
- no dates for withdrawal of the RAF have been put forward
- after disposal, the RAF will have very little influence on the future of the site
- the DIO, CO, AVDC and the PC to have a formal meeting to discuss the future of the site
- the local planning authority (currently AVDC) will have the final say in what happens
- the RAF were keen to keep communication open but very little information was passed on to the RAF Halton and those who work on the site
- everything will be sold to buyers, but the planning authority will know what can and can not be done

17.005 Open Forum

Members of the public commented on:-

- Historic England's rights over Halton House and the broader implications
- David Lidington's comments regarding the business case to dispose of the RAF site
- The officers quarters and the supposed length of the lease to the DIO when these might be sold off?
- Establishment of the rights of way over the site
- Disposal of the Tennis Club
- Demolition of the workshops
- Future of the listed buildings on the main site
- Impact on the Village
- Ownership of McEwan Ride
- PC website to be kept up to date on progress
- Excessive shooting with no prior warning (WC Stacey replied that the new indoor range should be up and running by the summer and that sometimes there is very short notice given for use by other units)
- It was confirmed that the site will be empty before 2022, when it will be sold.

and that it will be removed before the RAF leave.

- Trenches (Grade II listed) Currently there is ongoing embryonic discussions with AVDC, to include the museum. It would depend on who takes it on and how they would like to run the trenches.
- Closure of St George's? Eventually this will be happen and will be part of the draw-down plan. Until recruits go, everyone will stay in post.
- Future responsibility for roads? It is expected that this will be paid for by infrastructure levy from developers.
